RE: Drain tile or pipe system exemption

In accordance with SPS 321.17(2), Wisconsin Administrative code, the Building Inspectors in Waushara County may waive the requirements for a complete drain tile or pipe system for new one and two family dwelling construction where documentation is submitted which verifies that the soils in the area of the foundation are comprised of well drained sands or well drained loamy sands and that no seasonal groundwater levels exist at or above the elevation of the footing of the proposed new one or two family dwelling. The easiest way of documenting that these conditions exist is to simply have the Certified Soil Tester do an extra boring or back hoe pit in an area of the proposed basement while conducting the soils report for the private on site wastewater treatment system. This extra boring should be taken to the same depth as the depth of the proposed footings. Once this information is received, along with the attached waiver signed by the landowner, a drain tile or pipe system is not required.

In the instance of a proposed addition to an existing one or two family dwelling where the proposed foundation is at the same (or higher) elevation as the existing foundation, and it has been verified that there is no history of water problems, the signed waiver would exempt the addition from having a drain tile or pipe system, as well.
